**PUBLIC NOTICE NO : 03 /2020-21**

**Sub : Measures to make Bill of Entry Amendment Process contactless and paperless.**

Attention is invited to ICES Advisory 14/2020 dated 14.04.2020 on generation and emailing of PDF copies of eOOC and eGatepass. Further, following changes have now been introduced in the ICES to streamline the process of amendment of Bill of Entry and make such process electronic :

**a) Online Filing of Bill of Entry Amendment**

The facility for filing the Amendment Request online through ICEGATE has been operationalized. NIC's Remote filing software (RES package) has also been upgraded to include such Amendment Request filing. Once the Amendment Requests are filed online, the ICES would queue them before the Proper Officer. The additions made in Supporting Documents Table would continue to be Auto Approved while other Amendment Requests, including deletion/modification in Supporting Documents would require the approval by the Proper Officer.

**b) Electronic levying and payment of Bill of Entry Amendment Fee**

An option has been added in the Amendment Approval Form to enter the amount of Amendment Fees levied in terms of the Levy of Fees (Customs Documents) Amendment Regulations as amended from time to time. The 'Fees' can be entered by the Appraiser and can be edited by the group Assistant Commissioner/Deputy Commissioner. Since this field is mandatory, the Proper Officer should levy the Amendment Fee as per Notification No. 36/2017-Cus(NT) dated 11.04.2017. Once the amendment is approved and the Bill of Entry is assessed, the Amendment Fees will automatically get included in the Duty Challan for Electronic Payment through ICEGATE. An Email will also be triggered by the ICES to the Importer/Customs Broker informing about the Approval/Rejection of the Amendment Request by the Proper Officer along with the amount of Amendment Fees levied (in case of Approval) or the reasons for Rejection.

Considering their importance, particularly during the current Covid-19 crisis, all stakeholders are encouraged to avail the benefits of online amendment filing.

Difficulty, if any, faced in the implementation of this Public Notice may be brought to the notice of the Deputy Commissioner, Precious Cargo Customs Clearance Centre, Mumbai or the undersigned immediately.
